Duncan C. Stoddard was elected president and CEO of Chelsea Groton Bank in 1988. Duncan has over 28 years of industry experience. ## Duncan's banking career.

I was working in real estate sales in the year prior to beginning my banking career in 1974. Obviously in the real estate field I was having a lot of interaction with mortgage bankers in particular and became friends with Dick Creviston who was the president of the then Savings Bank of New London. We had discussed banking career opportunities on a couple of occasions. He offered me a job in management training at the bank, which I began in April of 1974. The management-training program



at that time was quite comprehensive and started right at the teller line. I worked on the teller line and eventually as the head teller for about 6 months before moving into mortgage lending, collections and installment lending. In 1977 an opportunity arose with Groton Savings Bank, which was in my hometown across the river. Al Ricker, then president of Groton Savings Bank, offered me a position as the branch manager of their Groton office. I managed this office for a few years and then moved more directly into the installment and mortgage lending areas. Through the 1980s I had increasing responsibilities in lending, becoming vice president of lending in 1985 and senior loan officer the following year. I joined the board in 1987 as corporate secretary and executive vice president. In 1988, I was promoted to president and CEO.
